## **Recommended Inspection and Servicing of Play Equipment**

EN 1176 (the standard for play equipment) recommends a number of inspections during the life of the play equipment.

Routine Visual Inspection- Should be carried out daily when the equipment is first used and each week, once the novelty has worn off, to check for obvious hazards that can result from vandalism such as broken bottles. It is not considered necessary to keep a written record of this inspection.

Operational Inspection- This is a more detailed inspection to check the operation and stability of the equipment especially for wear. This inspection should be every 1 to 3 months. A written record should be kept of this inspection.

Annual Main Inspection- This is carried out to establish the overall level of safety of the equipment, foundations and surfaces, effects of weather, presence of rotting or corrosion and any change of the level of equipment as a result of repairs made, or of added/ replaced components. This inspection should be carried out by competent persons in strict accordance with the manufacturer's instructions. A written record should be kept of this inspection.

#### **Routine Visual Inspection - Check List**

- 1. Play equipment and play area is clear of rubbish, foreign objects and clean.
- **2.** Foundations are not exposed, loose in the ground or cracked.
- **3.** All access and entrances free from obstructions
- 4. Safer surfaces undamaged
- 5. All loose fill surfaces level, without rubbish or fouling
- 6. Any signs of damage to equipment
- **7.** Any signs of ropes fraying and in particular no protruding wire.
- **8.** All fixtures, fittings and ropes tight see attached step-by-step guide.

#### **Operation Inspection - Check List**

- 1. As for Routine Visual Inspection
- 2. Check all moving parts, shackles and eyebolts for wear
- **3.** Components are secure with no excessive movement between them (which could lead to finger traps)
- **4.** All surface finishes have no sharp edges, splinters or rust.
- **5.** Check rubber safety surfaces for lifting of edges and growth of vegetation.
- 6. Complete written record of inspection

#### Material/Manufacturers Guarantee

After the first 2 Years, your guarantee moves onto individual material or manufacturer's guarantees. These are some of the longest product guarantees in the industry and are detailed in the table below. Where there is a fault with the product or material we have provided, we will provide a replacement part free of charge. Should you require this part fitting there would be an additional installation charge to fit the replacement, this may be mitigated if you are using Creative Play to provide inspection and maintenance services. Where 3rd party products or components are used, we will engage with the supplier to ensure replacement parts are provided within the manufacturers guarantee.

#### **Inspection and Maintenance**

As a playground provider, you have a responsibility under BSEN1176 (safety standard governing playground equipment) to ensure that your playground is inspected regularly. Not only does regular inspection ensure your playground equipment and surface is safe to use, but it also highlights any problems that are developing, and these problems should be reported as soon as they occur. We will ask for copies of your inspection reports and maintenance records if you make an enquiry under your guarantee.

Creative Play offers a range of inspection and surfacing packages to help you ensure your playground equipment and surfacing is kept in top condition, by using our maintenance services you may be able to avoid any additional installation charges for fitting faulty materials as they can be replaced at the same time as your inspection and service.

Rubber Mulch	2 Years	5 Years – guaranteed to meet the safety standards of BSEN1177. Does not cover shrinkage at edge profile whether grass, tarmac, concrete or timber. Colour fading, transfer or discolouration not guaranteed. Guarantee only applies when laid onto a stone sub-base (minimum 50mm depth)
Artificial Grass & Playsafe	2 Years	10 Years – guaranteed to meet the safety standards of BSEN1177. Does not cover shrinkage at edge profile whether tarmac, concrete or timber. Colour fading, transfer or discolouration not guaranteed
Rubber Grass Mats	2 Years	2 Years – doesn't cover damage caused by mowing
Freestanding Timber Equipment	2 Years	2 Years – against structural failure
Loose-fill Surfaces i.e. bark, sand, gravel.	N/A	N/A – these are landscaping products whose performance cannot be guaranteed
Metal Sports Fencing/Goals	2 Years	10 Years – against structural failure
Sail Shades, Polycarbonate Roofs, Timber Roofs	2 Years	5 Years – against structural failure. Doesn't cover damage by wind or snow

Should you need to make a claim against your guarantee you will be asked to provide invoice details, copies of inspection reports, photographs and details of the fault.
